Motion Rood/Buckley to approve agreement with Harrison Youth Soccer - \$1,500 for use of soccer field June 1, 2021 – October 31, 2021. All Ayes, Motion carried

Motion Rood/Willett to approve rubbish special assessment public hearing dates as July 13, 2021 and July 27, 2021. All Ayes, Motion carried


